# Youth Employment Opportunity Cultural Resource Technician Gulf Islands National Park Reserve - Parks Canada

# **Eligibility:**

Parks Canada is committed to diversity and inclusion and is proud to be part of the Youth Employment and Skills Strategy. We are committed to support youth gaining the skills and experience to succeed in their career journey.

To be eligible for the Youth Employment and Skill Strategy (YESS) program you must be:

- Between 15 and 30 years old
- Canadian citizen, permanent resident or legally entitled to work in Canada
- In addition, preference may be given to applicants who self-identify as an Indigenous youth, visible minority youth, youth with a disability, youth who self-identify as members of the LGBTQIAS+ community, as well as youth facing barriers to employment. As such, we encourage you to self-identify in your cover letter.

Gulf Islands National Park Reserve (GINPR) lies within the territories of the Coast Salish First Nations, including the Songhees Nation, the Esquimalt Nation, the WSÁNEĆ Nation (Tsartlip First Nation, Pauquachin First Nation, Tsawout First Nation, Tseycum First Nation, Malahat First Nation), and the Cowichan Nation (Cowichan Tribes, Halalt First Nation, Lyackson First Nation, Penelakut Tribe, and Stz'uminus First Nation). Preference will be given to qualified Indigenous candidates who self-identify.

#### A Day in the Life - Cultural Resource Technician:

Your day begins with arriving at the office in Sidney and checking in with your team to finalize a trip plan for a day in the field. You spend time reviewing the marine safety protocols and helping to load equipment on the boat. As most of the Gulf Islands National Park Reserve is accessed by boat, you often travel to the various islands by vessel, and have opportunities to learn about peoples' connection to these lands and water. While conducting regular cultural resource monitoring, you act as the eyes and ears on the ground as a technician and a steward of the park reserve.

Back at the office you maintain a site record with any changes observed in the field and update the database of cultural sites. In your job, you work closely with your team to share ideas and provide verbal and written feedback on cultural resource topics to better protect and present the cultural and natural history of the lands in the park reserve.
